# FUNDRAISING:

I/We agreed to participate fully in the PRWS mandatory fundraising requirement of \$500 per parent. It does not include Annual Giving, Holiday Faire, Scrip, volunteerism, or other activities. This requirement can be fulfilled by:

1. Making a cash payment to the school, which is tax deductible and can be rolled into your tuition payments OR

2. Participating in the PRWS annual raffle event, which cannot be rolled into your tuition payment, but must be met before re-enrollment next school year

**NOTE:** Any new fundraising activity must be coordinated through the PRWS Development office and adhere to PRWS fundraising guidelines.

### TUITION:

- 1. I understand the \$200 per student pre-pay discount is available on full pay tuition commitments only. My tuition will be paid in full by June 30th, 2017.
- 2. I will complete my payment plan (either ACH or post-dated checks for the year) by June 30th, 2017. I acknowledge that a \$250 late fee will be applied for payment plans filled out after this date.
- 3. I have read the tuition late payment policy in the parent handbook and agree to pay my tuition on time and in full.
- 4. I have read the early withdrawal policy in the parent handbook and understand that I am signing a contract with the following financial obligations:
  - Withdrawal prior to the first day of school: tuition through August is due.
  - Withdrawal prior to November 1, 50% of total amount is due.
  - Withdrawal prior to January 1, 75% of total amount is due.
  - Withdrawal on or after January 1, 100% of total amount is due.

### PARENT PARTICIPATION COMMITMENT:

All parents are asked to make the following commitments:

- 1. I will make my payments promptly.
- 2. I will participate in the fund raising event or pay the equivalent.
- 3. I will participate in the life of the school through volunteerism.
