2023-24 Re-Enrollment Registration Overview

Thank you for sharing in the mission of Pleasant Ridge Waldorf School, and for your investment in this inspired education. We're so glad your family is here!

Students Enrolled via the Wisconsin Parental Choice Program (WPCP):

- Complete the re-enrollment registration form and include each child currently enrolled in the WPCP as well as any other(s) you anticipate enrolling for the 2023-24 school year.
 - Note: you must also renew your child(ren)'s participation via the Wisconsin Department of Instruction (DPI) website between February 1 and April 20, 2023 to continue enrollment in the WPCP. Notification will be sent to families via email when the enrollment period opens for the 2023-24 school year.

All Other Students:

- Complete the re-enrollment registration form
- Remit Registration Fees:
 - Re-enrollment registration fee is \$50/child per private-pay tuition contract
 - Registrations received after 1/31/23 will include a late fee of \$50 per each month overdue

Tuition (per student) for the 2023-24 School Year:

- Grades 1-8: \$9,200
- 5 Full-Day Kindergarten: \$7,200
- 5 Half-Day or 3 Full-Day (Mon-Wed) Kindergarten (3 & 4 year olds only): \$5,000
- Extended-Day Kindergarten Option (3 & 4 year olds only): \$2,200

Financial Aid/ Tuition Adjustment Process:

- Families with demonstrated need may be eligible for an adjustment in tuition
- Tuition Adjustment Applications (and corresponding paperwork) must be submitted by 1/31/23 to guarantee consideration

Steps to Complete Enrollment for the 2023-24 School Year:

1. Complete and return the re-enrollment registration and household income forms along with any applicable registration fees to PRWS by 1/31/2023.
2. If you intend to apply for a tuition adjustment, tuition adjustment application and supporting documentation are also due by 1/31/23.
3. Schedule Participation and Financial Commitment (PFC) meeting to finalize enrollment contract. Here you will sign your PFC contract and submit a tuition payment plan.
